New public procurement directives to ensure that our industry's independent role is safeguarded

At the same time that the Commission launched the proposed revised directives, EFCA voiced its opinion in a press release.

EFCA welcomed several draft amended rules, in particular those directed towards greater transparency in the competition for service concessions, stronger support for innovation, the new emphasis on sustainable development in procedures and award criteria and improved access for SMEs to public markets.

EFCA voiced concerns about in-house contracts of public authorities, as a result of which a considerable portion of public sector services is withdrawn from the market.

Moreover, when the in-house status is abusively used, the testing of value for money through a competitive process does not take place.

It is therefore essential that the role of consulting engineers as independent advisors is preserved, so that they can be powerful vectors in fostering fair competition, throughout the project lifecycle.

Barometer to provide a snapshot of where the European industry is going

At their autumn 2011 meeting, the directors of EFCA member associations decided to develop a simple and internet based survey to have an overall reflection of short-term business developments.

A first exercise proved to reveal valuable information on turnover and profit trends over the past half-year and the industry's future outlook in 6 months' time.

A small working party now started the design of a standard survey and the planning of the analysis and format for reporting.

The national directors engaged to participate in the half-yearly e-survey on the current business situation and expected business activity. They will share the results at their meetings.

The information will also be reported on the EFCA website as from mid 2012.

EFCA-FIDIC closer cooperation emphasised

Jan Van der Putten and Enrico Vink as well as both federations' boards regularly review ongoing joint advocacy and actions.

Major common activities cover the following areas:

- **liability & insurance:** the co-branded FIDIC-EFCA policy statement on Limitations of Liability is finalised; a policy statement on joint and several liability will be jointly drafted;
- **industry survey:** the preliminary draft of the European section of the joint FIDIC-EFCA sector review, based on an analysis of national macro-economic data and sectorial reports is expected by March;
- **industrial engineering industry:** Enrico Vink is sitting on the task force, which will among other things, develop a standard agreement for the appointment of industrial engineering firms;
- **sustainable development:** the EFCA Board agreed to the potential merger of the FIDIC Sustainable Development committee, the FIDIC Climate Change task group and the FIDIC-EFCA Innovation and Engineering task group in the EFCA Sustainable Development task force. FIDIC is invited to appoint representatives from other regions. FIDIC and EFCA will provide support to the English translation of the Carnet de Bord Développement Durable (CBDD®) and be member of the consultative committee for the development of PSLB® (Project Sustainability Logbook), coordinated by Syntec-Ingénierie. The consultative committee's aim is to create a platform for the use of PSLB® and related database on standards, tools, indicators, best practices and regulation at international, European, and national level (i.e. CEN/ISO information respectively);
- **Young Professionals:** the respective YP groups will examine how to better work together and integrate activities.

AHCEA reports on Hungarian business trends and presents AHCEA agenda

At a joint meeting in Budapest, the AHCEA (Association of Hungarian Consulting Engineers and Architects) board and EFCA board members discussed major issues that have an impact on the firms.

AHCEA President Gyula Bretz reported on market developments and changes in business conditions.

József Éhn set out the major issues in the ongoing review of both the Hungarian and European public procurement law and highlighted the need for professionalising the procurement process to ensure long-term quality results.

Károly Lèderer explained the increasing activity of the AHCEA Dispute Adjudication Board and its internal collaboration to improve the process of resolving a dispute. The EFCA Board heard from József Visontai about problems in the translation of the Eurocodes in the national language.

Finally, four AHCEA Young Professionals presented their views on their professional future and the challenges to the European engineering consultancy industry.

EFCA President Jan Bosschem then explained EFCA's priorities. He expressed appreciation for AHCEA's effective communications on EFCA activities and policy wins with its membership and colleagues in the central and eastern European region.

Directive on concessions: completing the European legal public procurement framework

The purpose of a new directive on concessions is to propose a comprehensive, clear and unambiguous set of provisions in the area which so far has been characterized by a continuous uncertainty and erroneous interpretation.

The draft directive encompasses concessions in both the classic and the utilities sector.

The Commission considers a legislative proposal in the field of concessions as one of the key measures that will facilitate the setting up of PPPs, and as such considers it as a means of stimulating economic recovery in the context of the current economic downturn.

The Commission's proposals are transmitted to the Council of Ministers and the European Parliament with a view to launching the legislative procedure for their adoption, scheduled by the Single Market Act to take place before the end of 2012.

Revised Government Procurement Agreement (GPA)

According to the European Commission, the main gains of the revised GPA are 'more transparent rules for international public procurement, new market access opportunities and, accession and benefits for developing countries'.

The GPA governs the procurement activities of its parties and is the only legally binding agreement in the WTO on the subject of government procurement.

It is a multilateral treaty with 15 parties: Armenia, Canada, EU, Hong Kong, Iceland, Israel, Japan, Korea, Liechtenstein, the Netherlands with respect to Aruba, Norway, Singapore, Switzerland, Chinese Taipei and the United States.

New ePRAG Tool



A new online application is available, putting The Practical Guide to

Contract Procedures for European Union External Actions (PRAG) online in an easy to use format.

The PRAG contains all rules and templates that must be applied by the Commission and decentralised contracting authorities as well as those submitting tenders under contract award procedures for EU external actions. This makes it a very comprehensive, but increasingly hefty, set of documents.

With ePRAG, EuropeAid developed a more user-friendly application to enable users to search and access the guide and associated annexes.

The ePRAG application allows enhanced navigation through the ePRAG texts, leading users through sections, links and hyperlinks. Users also have the option to view the site and its contents in one of a number of languages.

Commission earmarks €96 billion for external instruments (2014-2020)

The range of instruments will support developing countries as well as countries in the European neighbourhood and those that are preparing accession into the EU.

This budget will also enable the EU to further reinforce its role on the global stage and promote its interests and values.

One of the major innovations and a key external policy tool is the new Partnership Instrument.

It will aim to advance and promote EU interests and to address major global challenges. It will also allow the EU to pursue agendas beyond development cooperation with industrialised countries, emerging economies, and countries where the EU has significant interests.

€62.5 million allocated to Eastern Partnership countries

The second part of the European Neighbourhood and Partnership Instrument (ENPI) for 2011 will address challenges in a wide range of sectors relevant for the whole region, such as integrated border management, territorial cooperation, youth, climate change and transport.

The EU supports the multilateral dimension of the Eastern Partnership (Armenia, Azerbaijan, Belarus, Georgia, Moldova and Ukraine) with a budget of €350 million over the period of 2010-13.

Plan for green growth and eco-innovation

Eco-innovation is crucial to delivering the Europe 2020 strategy for smart, sustainable and inclusive growth.

The new Eco-Innovation Action Plan is one of the commitments of the Innovation Union Flagship Initiative.

The Action Plan will accelerate eco-innovation across all sectors of the economy with well targeted actions.

Main lines of actions are in the areas of regulatory incentives, private and public

procurement and standards. It will mobilise support for Small and Medium-sized Enterprises (SMEs) to improve investment readiness and networking opportunities.

€80 billion programme for investment in research and innovation (2014-2020)



Horizon 2020 will bring together all EU research and innovation funding under a single programme.

Horizon 2020 is a key component of the Innovation Union flagship under the 'Europe 2020' strategy.

The programme will implement a number of Innovation Union action points, namely focus on societal challenges, simplify access and involve SMEs, support public procurement of innovation, facilitate collaboration, and support research on public and social innovation.

€2.5 billion Business Competitiveness and SME programme (2014-2020)



The proposed programme for the Competitiveness of Enterprises and SMEs (COSME) is a funding instrument that is largely continuing the activities under the current Competitiveness and Innovation programme (CIP).

It will focus on three general objectives:

- improve access to finance for SMEs in the form of equity and debt;
- improve access to markets inside the Union and globally;
- promote entrepreneurship.

The programme is expected to assist 39,000 firms, helping them create or save 29,500 jobs and launch 900 new business products, services or processes, yearly.

Encouraging funding of business

The Action Plan to improve access to finance for SMEs presents the various EU policies and measures to make access to finance easier for Europe's 23 million SMEs.

To encourage private investment, the Commission proposes two new regulations. The first will allow venture capital funds to raise funds across Europe for the benefit of start-ups, while the second will help investors to identify funds that focus on investing in European social businesses.

€3.2 billion budget for LIFE (2014-2020)

The Commission proposed to address environment and climate action as an integral part of all main EU instruments and interventions.

LIFE will coordinate the various sources of financing, will fill potential gaps and support 'integrated' projects.

In addition, the LIFE Programme, currently regulated by the LIFE+, will be continued.

The Building Performance Institute Europe (BPIE) analysed Europe's building stock (EU 27 as well as Switzerland and Norway) including building characteristics, building codes and other regulatory measures.

The survey provides an EU-wide picture of the energy performance of the building stock and how existing policies influence the situation.

Proposed reformed VAT system

The current EU VAT system no longer fits with a service-driven, technology-based economy.

The Communication on the future of VAT sets out the fundamental characteristics that must underlie the new VAT regime.

Objectives of the proposed changes are:

- VAT must be made more workable for businesses
- VAT must be made more efficient in supporting Member States' fiscal consolidation efforts and sustainable economic growth
- a more robust, fraud-proof system.
